Dear Sir

We did not get a quorum of our Com together yesterday & they adjourned to meet on Friday the 16th inst at a quarter before 2 O'clock P.M. at my office--

I hope you will make your arrangements to attend without fail--as the committee will have some matters to settle which concern all the Institutions west of the Mississippi alike-- this is the more important as you may were prevented from attending the Annual meeting of the Board indeed under the existing [relations?] of Directors of the Society & the Trustees of Pacific it is absolutely essential.

Moreover I have no doubt it will be beneficial to Pacific University

If you could come a little time before the meeting of the committee I should be glad but will not help press that point as I have no doubt your time is very much occupied.
