Dear Br,

We were greatly disappointed that you could not be present at our meeting. But it is evident that you had very strong reasons for remaining in Boston, and doubtless did right. I learned from Mr. Manning (who by the way delivered a noble address) that you wrote me on Monday at NY but I left the city before it reached me.

Our Treasurer was somewhat perplexed from not securing your Report and had to make up his account in an unpreferred way, that in a full view of our operations could not be given. The Board consequently have authorized the consulting com to incorporate your report before our annual Report is published.

The financial year closes on the 15th of Oct then the Treasurer has to make up the accounts and get it audited – I presume you have sent it on and I shall find on reaching New York.

Mr. Arthur has made the regular applications in behalf of the Trustees of Pacific University. We shall have a meeting of our Consulting Com soon when we should cut out work for the year and it may be way important that you should be present. Please let me know where I can address you.

I am happy to hear of your success in Boston. I present the [claim?] of the Society several weeks since in the place where I [reside?] and a New York gentleman who was present and became interested has since made a contribution of three thousand dollars (\$3,000)
